

IMPORTANT INFORMATION

1. **Pre-registration to participate in MCT residency begins April 1.** Fee is \$40.00 to participate. Pre-registration form may be downloaded from www.theparamount.net.
2. All who pre-register will be guaranteed a part in the cast. Specific roles will be assigned at the audition. **Everyone pre-registered must attend the 2 - hour audition.**
3. Please register for one performance so that as many as possible may participate. If you are interested in participating in both or available to participate in both, you will have an option to list a 1st and 2nd choice.
4. Each residency has a **limited** capacity. **REGISTER EARLY!**
5. No advance preparation is necessary for the audition, but a smile never hurts! It is a “group audition”. Students should just be ready to come and have a good time!
6. During the audition, 4-6 Assistant Directors (ADs), ages 10 and older, are selected to help teach and direct the show early in week as well as take on technical responsibilities at performance time. Their logistical help and creative ideas are a vital part of the process, and the experience of the ADs can be just as valuable as that of any cast member.
7. **Rehearsal schedule will be 10:00 a.m. – 2:30 p.m. Mon. -Fri.** This consists of two 2-hour sessions with a 30 minute lunch break in between each day. The first 2 hour rehearsal will begin after audition (12:30 – 2:30) on Monday for **some** of cast members.
8. **Please note that not all cast members are required at every rehearsal.** The youngest cast members (rising 1st grade – age 7) will begin their rehearsals on Wednesday and will rehearse the first 2 hour sessions for remainder of week, with possibility of both sessions on Friday. ***A complete rehearsal schedule will be given to the parent and child at conclusion of audition.***
9. Cast members involved in both rehearsal sessions will need to bring a healthy lunch/snack and water should that apply to his/her rehearsal for that day.
10. Cast must be able to attend all rehearsals required for their role.
11. Public performances - Saturday, June 26 and Saturday, July 24 at The Paramount Theater. There will be 2 afternoon public performances each day (Times TBA).
